TOURIST INFORMATION
about *TOURIST TAX*

Dear Customer,

we would like to inform you that since April the 15th, 2014 has become as a law in Orvieto the tourist tax provided by Clause 4, Legislative Decree of March the 14th 2011, n.23.

This tax is in order to finance tourism interventions, including support to accommodating structures, maintenance and use of cultural, artistic and environmental goods and for public services.

For the year 2018, following the D.L. n. 50/2017 converted into Law n. 96/2017, the Municipal Regulations were amended by City Council Resolution n. 120 of 27.12.2017 and by City Council Resolution n. 328 of 28.12.2017 and relative rates have been approved.

WHO MUST PAY THE TOURIST TAX

Tax must be paid, for a maximum of 5 consecutive overnight stays, by tourists who stay in all sorts of accommodating structures located in the municipal territory.

HOW IT MUST BE PAID

Overnight tourists must pay the tax in cash to the Landlord. The fee could be written down in the invoice, VAT excluded , or in a separated receipt

WHO IS EXONERATED

Exonerated from the payment of the tourist tax are:

Children till the age of 12

Resident

People who take care of patients admitted to hospital, one helper for one patient

Parents or carers of young people till 18 y.o. admitted to hospital, maximum two people for one patient.

Overnight tourists at Youth Hostels or accommodating structures property of the Municipal Administration.

Security Force Agents in service.

Guests of Orvieto Commune

People who stay in every facility for therapeutic reasons, by certification of the local Health Unit.

LANDLORD'S OBLIGATIONS

Accommodating structures' Owners of Orvieto Commune must inform their Guests about the tourist tax, its application rate and exemption rules.

Reduced Tax for groups more than 20 people	not expected	50% reduction*

*In accordance with the resolution of the Town Council n. 79 of 4/14/2016, the reduction of 50% is applied to groups who come by tour buses and have acquitted regular payment of the determinate rate for access and parking in the city.

The 50% reduction can only be applied to groups of at least 20 people who travel through package trip tour arranged and organized by Professional Organizer, having booked and staying in the same Hotel, apart from exceptional circumstances that can justify the use of different structures.
